From the Desk of Rev. Beth

My best friend gifted me the book *The Turquoise Table* last year and when I began reading it, I immediately knew we needed to read it as a church. The book is about how the author, Kristin Schell, was inspired to open the door to relationships and conversations in her neighborhood by putting a turquoise picnic table in her front yard. She was nervous in stepping outside of her comfort zone, but felt this was her mission field — to provide a welcome space for all to enter and share their deepest selves. Her passion and vulnerability was even showcased on the "Today" show as others have started putting turquoise tables in their front yards too.

It made me realize that the church needed a turquoise table too. I had spent the past several months looking for used picnic tables online but found them to be more than I could afford. Then, two days before we were scheduled to meet for our book discussion, someone told me that Star Drive-In was giving away their old picnic tables, so I called them up. They had one left and said it was mine if I wanted to come and get it. When my husband came home from work we drove over and with the help of two strangers, hoisted the 10-foot table in the back of his truck. As we pulled in the driveway at home, our neighbor across the street came over and helped unload it. The following day, we repaired rotted boards. We sawed, sanded, and painted (the actual color is the Pantone Color of the Year for 2022 called "Rolling Surf").

It was ready just in time for our book study. Our beautiful turquoise table. A place out in the open, a place for all to gather to invite authentic conversations during this unsettling and turbulent time. There are so many topics to discuss: COVID-19, distance learning, trauma, mental health, racism. There are so many wounds and hurts and frustrations that need sharing...and healing.

Our faith teaches us that healing happens at the table.

We each need to do our part. We need to listen.

Lead. Love. Learn.

At the table. The table is a safe place to face our vulnerabilities, ask questions, and reflect on experiences – good and bad. What matters most is the connection.

We need a few more turquoise tables in the world. Will you join me at ours?

You still have time!

Okay, the fun part of summer is officially over. It's September. The pandemic has been curbed. Back to communal worship and back to business.

We started the 40 for \$40K project soon after our congregation voted to approve the new annual budget starting in July. The vote by an overwhelming majority approved a \$43,000 deficit. The easy idea was that we could move money from our church "savings" to solve that problem.

Some think that is not the best idea. After all, we have been moving money from the so-called savings for several years. Soon, if this solution continues, we will have no savings.

So, it is in all of our hands to redirect our efforts.

Any increase in your pledge and **any first-time** pledge of your monetary gifts will go to reducing—or even eliminating—that budget deficit.

We suggest an increase or new pledge of \$20 a week for this effort. Pledges can be gifted weekly, monthly, quarterly or annually. So, that's \$20 a week, \$260 a quarter, \$520 for six months – or a one-time yearly gift of \$1040.

If you were a member of a club, a sorority, a fraternity, you would be paying dues to belong. Church is not like that. We have no mandatory member or participant fees. We simply ask that you give what you can to keep our congregational experience alive and well.

Kids Church

(formerly known as "Sunday School")

I am so excited about Kids Church this year. So many wonderful events and happenings are going to take place. It will be a year of surprises! This year is being divided into quarters — we will lead off each quarter with a new fun activity that will introduce the theme. Here's what it looks like:

The first Sunday following Labor Day weekend, **September 11**, will be a **WELCOME BACK SUNDAY!** Everyone is invited back to church and come together in the Sanctuary – it has been a while since adults and children have been together in worship! Following the service, parents will have an opportunity to fill out registration forms for Kids Church.

September 18 will be **CELEBRATION SUNDAY**, and will kick off the Kids Church year with a **special, fun activity** in which all the children of the church will participate. (Girls and boys, you will find out what that activity is when you come to Kids Church that day.) You will also meet your first quarter Kids Church teachers.

October 2nd is another Sunday we are urging you to attend. It is a Sunday all third, fourth, and fifth graders (and maybe more) will receive something special.

We will kick off the Kids Church year with the **Spark Program curriculum Activate Your Faith.** The teacher will prepare the children to hear the Bible story, open the Spark Bible, and explore the story in

interactive, age-appropriate ways. The children will try a variety of multisensory activities that integrate Bible learning with life. The children will come together at the end of the lesson with a wrap-up and closing prayer.

The second quarter will explore **Advent,** the stories that lead up to the birth of Jesus. The culminating activity for this quarter will be determined by the students and teachers.

The third quarter the children will learn about **Heifer Project**, why we participate, how what we do helps other families around the world, and finally we will raise funds for Heifer with the culminating event (and a favorite of all the children), the Living Gift Market.



Four weeks remain where the children will spend one week reviewing each quarter with fun games and activities (April 23, April 30, May 7, May 14).

We will have a different team of teachers working with the children each quarter. Each team will teach their particular subject area for **7 weeks**. Each team will have 3 teachers; one will work with pre-k & K children; the second teacher with grades 1 & 2; the third teacher with grades 3 to 6. The children who are 12 will be assigned to a teacher each quarter. Their role is twofold – to continue learning about the Bible; and learning to serve their Kids Church class and the church according to their gifts.

For Kids Church to work this year we need your help. We have set up the Kids Church program this year so teachers may attend worship most of the church year: each teacher only needs to volunteer for 7 weeks. Will you volunteer for 7 Sundays?

Each program will have some culminating event. You may be needed for one Sunday, or a few Sundays. Will you volunteer for one Sunday, or 2 or 3, specifically for this special event?

CSCC Cabinet Meeting - Minutes August 17, 2022 at 7pm

The meeting was called to order at 7:02 by Anne Malmquist.

Cabinet members in attendance: Rev. Beth Stotts, Pastor; Anne Malmquist, Moderator; David Sheibley, Treasurer; Diane Sheibley, Clerk; Deb Sorgman, Board of Trustees; Gordon Brailsford, Board of Trustees; Bill O'Neil, Board of Christian Outreach; Kathleen Mosher, Board of Stewardship; Terry Reynolds, History & Memorials Committee; Jane O'Connell, Women's Guild & Fellowship; Ellen Crawford, Music Committee.

Also present: Mary Barnsley, Lynn Pietras, Gail Wright, Connie Chandler, Carol Chaffee

Rev. Beth opened the meeting with an excerpt from "The Turquoise Table," and a prayer.

June Minutes

The meeting minutes from the June meeting were presented and reviewed. Deb Sorgman motioned to accept them; Dave Sheibley seconded. The minutes were approved.

Pastor's Report – Rev. Beth Stotts

Rev. Beth talked about the "Community Give Back" Night at Black Hat Brew Works that she organized. (October 6) 15% of all of their sales that day will be donated to CSCC. She also developed the worship schedule for the 2022-23 year. She oversaw the transition to a new Congregational Receptionist. She also put together the Junior Choir information, and four kids have already signed up to participate.

Questions ensued regarding the circumstances surrounding Deborah's departurefrom the Congregational Administrator position. It was noted that a 6-month performance review was conducted, noting several specific areas of concern that needed immediate improvement. At the time her 1-year performance review was conducted, those areas had not satisfactorily improved. The chair of the Trustees, the chair of the Deacons, several officers, and Rev. Beth deliberated on the situation, and the decision was unanimously made to discontinue her employment.

As with any transition, opportunities were created. Diane Sheibley offered to take on the role of Communications Coordinator, to not only help keep the messaging of the church consistent across different media and among various ministries, and offering more organized marketing, but also took some responsibility off the front office position. This allowed for less of a time commitment needed, thereby reducing the cost of that person. And with

the front office position primarily focusing on greeting and tending to visitors, answering the phone and email, and working with the outside groups and renters, an adjustment to "receptionist" from "administrator" seemed appropriate.

Bill O'Neil noted that Jack Melcher resigned from church membership, and stated that it was largely due to Deborah's termination.

Rev. Beth went on to note that there will be a membership class / info session next month (Sept. 14) via Zoom. It was asked what membership really means at CSCC these days; some of that will be answered during the session. Anne also noted that the Constitution & Bylaw Committee is reviewing exactly that topic (among others); what does the "new" version of membership mean? How does it relate to those who worship with us virtually? The world operates differently now.

Treasurer's Report – Dave Sheibley

We had a pretty good first month of the fiscal year. That is partly thanks to the 40-for-\$40k project (thanks to Gail Wershing and the Board of Stewardship); some people prepaid the year's additional pledge, so that helped. There were no unusual expenses, and the investments are going back up. We're doing better than we have in a while. It was asked if people are using the online avenues of making donations; Dave responded yes.

Bridgewater Food Pantry - Bill O'Neil

Bill noted that we have seen an uptick in the number of pantry users recently; up 62% in 2022 over the same period last year. We're still getting donations from Aldi's and Stop & Shop. We're running low on nonperishables and could use some donations. We're also giving out gift cards to pantry attendees. Connie & Steve Chandler have been helping to deliver to shut-ins.

Historical Church Building Committee – Anne Malmquist for Barbara Morey

At the town's CPC June meeting, the committee could not all agree to committing to our Phase 2 & 3 proposals at that meeting. At the town's CPC July meeting, voting on approval of Phase 2 & 3 was to take place and Barbara was going to insist on their giving us an approximate \$ value for each phase. But the meeting was cancelled because they did not have a quorum. At the town's CPC August meeting, the CPC will vote on approval of Phase 2 & 3 and Barbara will ask for a \$ value before CSCC signs a deed restriction (which they

have said is required to accept the Phase 1 grant). She will then take this information to the Board of Trustees, and ask for a special meeting.

Gordon added that we still don't have a copy of the original grant agreement; and the CPC committee needs to agree on whether the siding needs to be removed or not. He also noted that balance between the commitment for funds from the town and the work to be done, is that, for example, the staging alone will cost \$80,000.

Governance Review Project – Anne Malmquist

Anne noted that this committee is made up of herself, John Sharland, Gail Wershing, Sherley Phillips, and Rev. Beth. The next meeting is expected to be in September.

They are working on how to structure governance in today's world, and have looked at other churches' models. Rev. Beth pointed out that just about every other church is going through the same thing as us. It was asked if the UCC puts out any guidelines to help. The answer was that any guidelines they have reflect how we're currently structured.

Care Team – Carol Chaffee, Care Team Member

Carol noted that she talks to a lot of people, and there are a lot of them who are truly concerned about our church. Will we work to preserve the church building, and then not need it? With the virtual atmosphere, is the building going to be obsolete?

Many people realize that 20% of the people do 80% of the work, and that weighs heavily on people. There is concern that there aren't enough checks and balances, and may be conflicts of interest. We have to trust God and each other, but what does membership look like today? What are the commitments of pledges? The hope is that people will come back to church, but membership looks very different with members of the church community being increasingly geographically diverse.

Rev. Beth noted that we're in a time of grieving; a post-COVID grief, with what it took away from us and our traditional practice of church. We need the community of church and the church family, and the kids are missing out, and want it.

Autumnfest - Diane Sheibley

Diane proposed that the church have a food booth at the BBA Autumnfest community event on 9/24, as a fundraiser. We could sell walking tacos, baked goods, maybe pies. She is willing to do the prep work and make all the arrangements, but needs people to work the booth from 10-3 that day.

Deb Sorgman said she'd help in advance. Gail Wright will work the booth if there are others to help. Carol Chaffee will help for the last hour and with cleanup. Diane will work on getting other volunteers to man the booth.

Coffee Hour – Diane Sheibley

Diane asked if coffee hour would be starting up again in the Fall, since it's been on hold since COVID hit, and who would be organizing it. Discussion ensued. Making coffee seems to be the real roadblock to getting volunteers. It was decided that it would be done by volunteers week to week who would be willing to bring a snack to share. Coffee may or may not be available. It will be called "Fellowship Time" instead of using the word "coffee" or "hour". Perhaps we should have a decorated wooden spoon that would be passed from one volunteer to the next each week to indicate who's responsible. Rev. Beth will work on a spoon. She will also be responsible for the first week of snacks, 9/11.

Sunday School / Kids Church – Terry Reynolds

Sunday School will be called Kids Church this year. There are about 20-25 kids eligible for Kids Church this year (3 yrs -> 11-12 yrs). It will be run in quarters so no adult needs to commit to the whole year, and miss worship. 1st quarter—sparks bible curriculum; 2nd quarter-advent; 3rd quarter-Heifer; 4th quarter-Lent. Different teachers for each quarter. Parent volunteers will help the teachers with individual Sundays. Terry has almost all of the teachers she needs, and materials have been ordered. Welcome back Sunday will be on 9/11 (all kids will stay in worship); Celebration Sunday, when Kids Church will begin, is on 9/18.

Fundraising Idea – Thrift Shop – Connie Chandler, Lynn Pietras, Gail Wright

Connie asked if the church would be open to hosting a thrift shop. She said the ones that exist now do very well and are quite popular. The small room under the stairs could be used to store items and clothing racks, and then during the open hours of the shop, items could be brought out and displayed in the fellowship hall. Perhaps just begin with a day or two a week. Need to check if we need a permit from the town. It was asked about where things would be stored that have been stored in that room, like Warmth in Cold Places items. It was noted that there are other places in the building, like in the extra office, or downstairs in the youth room. A core

group of people would need to be in charge of staffing it. It would be clothing as well as other items.

Cabinet indicated that it is in favor of the idea. Connie and her team will talk to the Trustees regarding the details and logistics.

Board of Trustees – Gordon Brailsford

Gordon noted that we need a new endowment fund manager, with the resignation of Jack Melcher. The eagle scout project is moving forward; Nic is currently doing fundraising and planning. Sexton Rich Sullivan would like to refurbish the window shutters in the sanctuary, and he still needs a couple more volunteers to help uninstall and reinstall them. Gordon noticed that in the sanctuary ceiling, some of the insulation had been moved for the initial renovation inspections. He put It back where it belongs. There was an issue of one of our trees encroaching on a neighbor's property and on our office windows, and Bruce Maclay trimmed it all back. There are also some gutters missing, and the Trustees are working on addressing that.

Board of Deacons – Deb Sorgman

Deb noted that as Fall approaches, and we get back to worshipping in person following COVID, there is again a need

for readers, greeters, and ushers. The website (events page) has an online signup available, or people can contact the office.

Board of Stewardship – Kathleen Mosher

The 40-for-\$40k campaign is doing well. We currently have 15 participants.

Women's Guild & Fellowship – Jane O'Connell

Jane reported that she came across a set of bylaws for the WG&F that says it was started in March of 1922. At their opening meeting in October, they will be celebrating the 100th anniversary. She also noted that she has a box of historical stuff that should be stored at the church, and she'll be bringing in.
