Annual Meeting Minutes, February 12, 2023

Moderator Anne Malmquist called the meeting to order at 12:00noon, and welcomed everyone to the meeting.

Clerk Diane Sheibley verified that a quorum was met.

#### **Moderator – Anne Malmquist**

Anne noted that this year, there will be a revamping and rewriting of the church governance documents. An email went out to all, and a USPS mailing will be going out this week. Next Sunday there will be a Q&A after church; please bring any questions. A quick overview of what is planned is moving from boards and committees to a team format. The goal is to have a congregational meeting in mid-March, to vote it in and implement as of July 1.

#### Pastor - Rev. Beth Stotts

Rev. Beth had a slide show on last year; she was struck by how much we've done. A special thanks to Paul Holmes and BTV for their ministry. She noted that she has also spent a lot of time making our church visible in the community.

#### Music - Julia Scott Carey

Julia noted that it was great to see the numbers coming back to the building [after COVID]. She reported that the junior choir members love singing, and we love to see them. The adult choir performed every Sunday. There have been a lot of guest artists, and they are always so happy to be here. There is a piano concert coming up in March [with Julia performing], and she is always thankful of all the ways to keep offering more music.

#### Video Evangelism – Paul Holmes

Paul reported that he has been working a lot on sound this year. BTV has been really good to the church, and we truly appreciate it. The numbers of viewers: a good solid 700 per week, and that's without the BTV numbers. Currently, the services are aired on YouTube, our Facebook page, BTV's Facebook page, and BTV Channel 9.

#### **Treasurer** – Dave Sheibley

The fiscal year ending 6-30-22 saw a net loss of \$63,812, versus a budgeted loss of \$42,135. There was some needed construction done during the year, although about 80% of the ceiling repairs in the sanctuary were covered by insurance. Fuel oil and electricity continue to go up in price. Most of the other budget items ended up about where we expected. The 40-for-40k program by the stewardship committee has brought in thousands of dollars this year. The fair brought in the most it ever has, about \$9,000, but the golf tournament never happened, so there was a hole in the fundraising there. The new thrift shop is doing really well and is a huge help. We need to find more ways to bring in money – all ideas are welcome!

#### **Annual Report**

A big shoutout to Jenne in the office for creating the annual report!

**Board of Outreach, and Bridgewater Food Pantry** – Bill O'Neil

The Food Pantry is still in need of food, and the demand is high. Regarding what to donate, "if you like to eat it, we want it." Big shoutout to Steve and Connie Chandler for all of their help. Patrons can only get food once a month, but the Food Pantry has gift cards they can also give them. Jack [Melcher] makes sure that everybody who comes and needs food gets it.

#### **Board of Trustees** – Gordon Brailsford

Special thank you to Rich Sullivan, who does an outstanding job as Sexton. The town has assigned us \$200,000, but they require a deed restriction on the whole church, but they haven't given us a copy of the deed restriction yet.

#### Church Fair Committee - Diane Sheibley

The fair did better than ever this year. Thanks to all who participated in every way, and a special shoutout to the crafters for their strong sales during the fair, as well as occasionally after worship, and at Christmas on the Common.

### **Board of Stewardship** – Kathleen Mosher

After the stewardship campaign, the committee is working on various fundraising ideas. There is an Amazon wish list for people to gift the church needed supplies. They are working on having posters with a QR code for donations for outside events. If you have any ideas, bring them to us.

#### Women's Guild & Fellowship – Jane O'Connell

The Women's Guild had a good year of rummage sales, and giving money to the CSCC service project as well as operating budget. They are looking for more (younger) members.

#### History & Memorials Committee – Barbara Morey

The committee coordinated the sales of poinsettias at Christmas, and the lilies at Easter. The flowers decorated the altar, and then the ones that people didn't want to bring home were delivered to shut-ins. The committee also keeps a record of those who have passed away. Last March, they went on a "field trip" to BSU, to see old, old records of CSCC, which they agreed are best kept at BSU. The undesignated memorial fund that they manage, with the little donations in memory of someone, is currently \$6600. H&M is looking for ideas on what to spend it on. Following a question, Barbara noted that larger bequest amounts are handled by the Trustees, and can be restricted or unrestricted based on the wishes of the giver.

#### **Historical Church Building Committee** – Barbara Morey

Committee members have been attending the town CPC meetings, the fourth Wednesday of every month. CSCC is always on the agenda. The deed restriction for our first grant is still with the Rhode Island consultant. Barbara has told the CPC that we need a yes or no on other future funds before we agree to a deed restriction on the building. Likely what would be in the deed restriction would be that we cannot sell the building, and that the building would need to be maintained to its original condition.

### **Central Closet Thrift Shop** – Connie Chandler

Connie noted that the thrift shop has been a dream from last June, and opened last month [January]. It is a service to the community, a good way to repurpose items, and brings in funds for the church. It is open Wednesdays and Saturdays, 10-1. They have had a lot of shoppers and donors.

### **Approval of Annual Report** – Anne Malmquist

Mark Sorgman motioned to accept the annual report. David Hanson seconded. The motion was approved.

### Report of the Pastor

12 years ago, when I was searching for a church to serve, I was drawn to Central Square Congregational Church, UCC after reading the mission statement. In our mission statement, we are very clear about how we will be together and how we will serve. A church is useless if there is no mission and our mission is clear:

We are a Christian community of people, reaching out to our neighbors, at home and abroad, sharing our faith and our resources.

#### We are a Christian community of people:

We are a people journeying together to learn more about how God is speaking in our lives, and how we can live more faithfully. We study, we pray, we serve, we worship, and we engage in great fellowship together. This year we offered many special worship services including the Thanksgiving Ecumenical Service, baptisms, vow renewals, weddings, guest preachers, communion, summer outdoor worship, and our annual Easter Sunrise service at Hanson Farm. We have meaningful conversations when we meet "at the table" during breakfast Sundays. We contemplate how we best follow Jesus by joining Lenten and Advent Book studies, Bible studies, and discussion groups. And we gather together for weekly worship, both in-person and virtually (thanks to the incredible ministry of Paul Holmes) providing multiple avenues for our congregation to engage with God and worship together.

### Reaching out to our neighbors at home and abroad:

Our outreach ministries continue to expand to meet the growing needs of our community. Through the Bridgewater Food Pantry housed at CSCC, homeless outreach, and partnerships with local organizations and non-profits, we have been able to extend God's love and compassion to those in need. Our church continually supports mission efforts through our special offerings and our emergency fund to meet the practical needs in our community and beyond.

#### Sharing our faith and our resources

Throughout the year, our church engaged in a variety of ministries aimed at sharing our faith within the congregation and beyond. Our choir and worship team continued to lead us in heartfelt worship, lifting our spirits and drawing us closer to God. We offered a variety of programs to help our members grow in their faith. Our youth and children's ministries have been active; providing a nurturing environment for young disciples to learn, grow, and develop their relationship with Jesus and each other. Our pastoral staff and care team has offered counseling, support, and care to those in need, providing a safe space for healing and restoration. And there isn't a day in the week when our building isn't being used by the community.

Looking ahead to the next year I am filled with hope and anticipation for what God has in store for us. As we seek to continue to live our mission, I am prayerfully considering our priorities for the next year.

- \*\*Deepening Discipleship\*\* I pray we will commit ourselves to providing opportunities for our members to grow deeper in their relationship with God through discipleship, study, and spiritual formation.
- \*\*Expanding Outreach\*\* I pray we will aim to broaden our impact in the community by expanding our outreach ministries and developing strategic partnerships with local organizations and churches.
- \*\*Strengthening Community\*\* I pray we will recognize the importance of fostering authentic community within our church family, and commit ourselves to continue to create spaces for fellowship, connection, and support.

\*\*Investing in Youth\*\* I pray that we will see the importance of investing in the next generation, and we will commit ourselves to provide resources, programs, and support to help our youth grow in their faith and leadership skills.

\*\*Embracing Innovation\*\* In a rapidly changing world, I pray we will embrace innovation and creativity in our ministry, seeking new ways to reach people with the love of God.

I believe that God has incredible things in store for our church community, and I am excited to journey together in faith as we continue to follow God's call.

### Report of the Minister of Music

2023 was a wonderful year in the musical life of the church. Our adult choir has performed an Anthem and Introit in every service between Labor Day and Memorial Day, with the exception of some holiday weekends. The adult choir continues to sing varied and challenging repertoire. They are able to learn music quickly and effectively, always presenting an expressive and meaningful performance. Some adult choir members have shared their gifts with us in solo performances as well. Brian Gilman has contributed several beautiful solos this year, and Peter Glass has joined us on trumpet, including performing some of his own amazing compositions.

We have also been extremely blessed with to have several children contributing to our church's music. Josephine Stotts has performed a vocal solo every month this year, and her confidence and musical expression has really blossomed. She has sometimes been joined by Savannah Wells, who in addition to singing, has also demonstrated her terrific flute skills for us. Cristianna Ciaramitaro has also shared her phenomenal vocal talents in our services.

Other regular guest artists in our community include the pianist and vocalist Bob Richards, who performs at least one powerful and moving solo a month, and jazz trumpet star Cameron Shave, who is always ready to give our services a special touch of excitement whenever he is in town.

We have had a number of guest artists visit our church from outside of our community. These guest artists are professional instrumentalists and singers who are artistic collaborators of mine, and many of them have performed on the world's finest opera and concert stages. Some of the guest artists who have returned multiple times to our church include soprano Sarah Vitale, mezzo-soprano Sarah Heltzel, and baritone James Dargan.

We have also hosted several special musical events this year, including a solo piano concert performed by me last spring, and a very exciting evening of opera arias this fall, featuring soprano Maryte Bizinkauskas.

One very moving event that occurred last spring was Lin Schuller's Celebration of Life, for which our choir was joined by a large number of guest singers who were friends and colleagues of Lin's. It was the most fitting and meaningful way to pay our respects to Lin's life and legacy — filling our church with the sound of voices praising God through the gift of song. Lin was my predecessor as the Minister of Music at the Central Square Congregational Church, UCC. I had the honor of knowing her and collaborating with her, and I learned so much through her leadership — how to use music as a form of spiritual expression, how to bring the community together through singing, and how to communicate the meaning in all the music we share with our congregation.

It has been a true joy for me to be the Minister of Music at this church. The adult and children's choirs are amazing to work with, and their performances and dedication are very inspiring. I love to plan the services and to think about the message which we are trying to convey in each service.

I will very much look forward to a wonderful 2024 and to the musical opportunities this new year will bring in our church!!

### Report of the Church Treasurer

Because the Annual Report is published before the June 30 end of the fiscal year, this was written May 15.

Fiscal year 2024 appears to be an improvement over the past four years, we should meet or exceed our budgeted amounts for giving and total income. However, we are still going to finish the year having taken almost \$40k from our dwindling investments to fund operations. The Church Fair continues to make a large contribution to the budget and the CSCC Thrift Shop revenue has surpassed expectations. Thank you to all who help with these and with other methods of fundraising! Expenses were mostly in line with budgeted amounts with no major expenses incurred thus far. However, one of the oil burners has been deemed unfixable by the insurance inspector so its replacement will be a fairly large expense before this fall.

Financial reports for this fiscal year to date are attached and the annual report on our website will be updated with final figures by mid-July.

### Report of the Spiritual Engagement Team

With the Covid-19 pandemic playing a less prominent role than in years past, worship and Kids' Church returned to more normalcy than in the past couple years.

Worship was in person every Sunday this year as well as additional services during Holy Week and Christmas. There was good lay participation throughout the year with ushering, greeting, and reading scripture, but more lay participation should be a focus going forward. There was lots of visible kids involvement and visibility in the form of ushering, acolyting, and serving communion.

Julia Scott Carey lead both the Choir and the Jr. Choir throughout the year and we had a number of high-quality guest performers come in to perform throughout the year.

We also implemented a new procedure for prayer requests so that people who were uncomfortable speaking up during 'celebrations and concerns' could write their prayer requests on a mustard-colored paper at the end of the aisle so they could be included in the Mustard Seed Prayer List insert in the weekly bulletin.

Rev. Beth and the Deacons changed the formatting of how confirmation is done this year, to better match the youths of 2023-2024, versus what has traditionally been done. Instead of multiple weeks of meeting for an hour at a time, this year the in-person portion was done as an intensive multi-hour worship/meeting. Communication on statements of faith, etc. were then done via email and text which allowed it both to be done at the convenience of Rev. Beth and the Deacons, as well as the convenience of the confirmands.

With the restructuring to a team format, we added a new Deacon, Anne Malmquist. Jae Stotts, is stepping down as a Deacon at the end of the year having completed her 3 year term and with her going off to college in the summer. Deb Sorgman continued to lead the Deacons and handle worship responsibilities alongside Rev. Beth. Eric Stotts stepped in as the Director of Kid's Church.

Kid's Church also returned to a degree of normalcy, with 26 kids attending at least once throughout the year. With that being said, attendance varied wildly from week to week from as little as 3 kids, to upwards of 15 during some weeks in December and May. Ashley Earp stepped in and was a full time teacher throughout the year alongside Eric Stotts. We also had assistance from Denise Molinari who ran the Advent programming and Krissy Cannizzo who ran the programming during Heifer.

For Advent, Kid's Church collected toys both from the congregation and the community for the Cardinal Spellman School, and had a Christmas tree in the back adorned with handmade ornaments that were made by the late Lin Schuller that were decorated by the kids.

Heifer continues to be a favorite event for both Kid's Church and the congregation. Between what was raised in church and at the Living Gift Market, the kids raise a total of \$1,330.

We also had 2 church sleepovers this year, something we had not done since before Covid. They were well attended with 9 and 12 kids attending respectively and were done at the tail end of February and April vacation.

With the assistance of Reverend Beth, The Spiritual Engagement Team also did a complete rewrite of our Child Protection Policy to conform with the church's current governance structure, as the previous version of the policy was over 3 years old.

### Report of the Property & Finance Team for 2023-2024

The Property & Finance Team of three elected members replaced the Board of Trustees last June as we adopted our new form of governance and a new constitution. Dave Hanson, Mark Sorgman and John Sharland accepted one-year terms. In the spirit of the new constitution, we divided up who would attend the monthly Cabinet meetings as our representative, each attending two meetings in a row. This has worked well. Dave took December and January, which are relatively slow months for a vegetable and small livestock farmer.

We met monthly throughout the 12-month period, dealing with lots of small things, maintenance-wise, and some big things. With the assistance of Dave Sheibley, leaving off where Gordon Brailsford had started, and with help from the MassSave commercial programs, all remaining light fixtures in the building were converted to LED. There are 5 hard wired smoke detectors in the sanctuary. One failed and because they were all 25 years old, it was decided to replace them all. This got expensive because staging needed to be brought in.

Two big things have put us in further financial peril, beyond the large deficit budget passed at last year's annual meeting. First, for all the right reasons, we abandoned the effort of receiving a grant or grants for the historical preservation of the building from the Community Preservation Act. We had to spend money up front to provide the estimates needed to preserve the building. That cost us \$110,000 from our reserves. We know of no feasible way, currently, to restore that money to our endowment. Second, we have been informed by the State of Massachusetts boiler inspector that our smaller boiler is in such bad condition that it has received its last operating permit renewal. It has to be replaced. We are getting three estimates for that now. We believe the cost will be in the \$15,000 range. Right here, right now, we ask for those who could, to provide a one time gift to the church that we can aggregate to pay for the new boiler. Your gift will be duly recognized on the Boiler Room door with a plaque.

A comprehensive list of fundraising ideas was created by a team that consisted of Lynn Pietras and Sandy Kuipers. This list was published in Steeple Sounds. Please take a look at the list and see if there is an idea that you would like to take the lead on.

Last but not least, a huge ongoing thank you to Rich Sullivan, our sexton, Steve Chandler, who fills in for Rich when needed, Dave Sheibley for essentially being the fourth person on the P & F team beyond his official role as treasurer, Larry Brown, assistant treasurer and Judy Pino, Financial Secretary. And of course, Gordon Brailsford, who has so often lent a hand to help with the responsibilities of this team, for many, many years and continues today.

### Report of the Congregational Engagement Team

The Congregational Engagement Team encompasses all the ways and avenues that our congregation is engaged in worship, parish care, welcome and fellowship.

Both Ginny and Kathleen were already deeply immersed in church fellowship activities as well as managing a busy lifestyle so they decided to step back, resign and continue to devote their time where their time was already devoted. The team itself works for the good of church, of course and has tried to provide new opportunities and new ways for our congregation to come together.

• Care Team – supports Rev. Beth in providing meals, visits, cards and a presence in the lives of our church community. The Soup and Share model have worked well for a small group to come together and make soup in our church kitchen, take some home and share some with other church members or friends in the community. The event has been on Saturday mornings during Thrift Store hours and has

- a potential to grow over time in to a regular event. Anyone who wants to be "Chef for the Day" and lead of group is welcome. If you have a recipe of any kind that you want to share let's talk.
- Fellowship Connie Chandler and Ginny Young have done an extraordinary job in hosting coffee hours on non-breakfast Sundays, providing that second hour of worship in our fellowship hall. Connie and Ginny have devoted their time, talent and treasure to these times. Behind the scenes, also, there is a consistent group of volunteers that assist with the coffee hours and others are always welcome. The Congregational Engagement Team has included some funds from its budget for coffee hour supplies.
- Other Marci Langevin and I were passionate about re-inventing our Christmas Caroling Model. We held a caroling event at the senior housing at Heritage Circle, Bridgewater and the event was well attended by the residents. Nina Gabel-Jorgensen and I had fun leading the carol sing, offering goodies made by Jenne Foronjy and Cass Travers, and also sharing our memories and traditions with one another. Unfortunately, Marci was sick at the time, but we will be making a plan for December 2024.
- Short term commitment opportunities These really do exist!! With Rev. Beth's forethought, we have sign-up sheets for ushers, greeters, liturgists and breakfast crew help. We have passed the sign-up sheets during worship, made them available before and after worship, etc. and the response has been good. Being ourselves, being Christians, it is so important to be present, to be welcoming, to be vulnerable to each other and to the newcomers that walk through our doors.
- Memorial Flowers we had success with our memorial Poinsettias and Easter lilies this past year. We tried having the Poinsettias earlier in the month of December but they do require a lot of care and the Poinsettia is a very temperamental plant. Some more thought will be devoted to our memorial plants. I have found a local source that services other local churches with holiday plants.

The year, really 9 months, has really been a rebirth of how our church functions with this team model as opposed to a committee model. There are so many possibilities and so many opportunities to try new things and with success comes growth. We shall raise this "child" together as a team with God as our focus and Jesus Christ as our leader.

### Report of the Community Engagement Team

We were a newly formed team of three. We were trying to figure out our responsibilities, who we were as a team and which direction we were heading. Rev. Beth came to us with a plan to form a mixed generational group for a service trip, made up of people within and outside of our church. All things were in place to sign up people interested in traveling to Maine provided by a group called MATE. Unfortunately, not enough people signed up. As a result, the church did not participate in the Service Project. We need to rethink this mission and decide if we want to tackle it next year or sometime in the future.

We looked at the 5 for 5 offerings and knew they should be part of our team's responsibilities. In October we tackled Neighbors in Need which supports Ministries of justice and compassion throughout the United States. In December the Christmas Fund was collected to care for active and retired clergy and lay employees of the UCC. We continued the 5 for 5 in March by collecting the One Great Hour of Sharing offering. This offering literally changes lives by providing clean water, food, medicines, shelter healthcare, education and so much more. May is the month for Strengthen the Church which is collected on Pentecost Sunday. This offering funds initiatives for leadership development, new churches, and youth ministry. The last of the five is collecting to support the UCC which helps the church in so many ways. One way is to provide a list of ministers and their profiles for churches searching for a new minister. One more offering beyond the 5 for 5 is Blanket Sunday. We asked Carol Chaffee to lead the Blanket Sunday collection by demonstrating how a blanket could be used to keep your body warm and also how to make a shelter to protect from the wind and rain to name a few. These are two ways blankets are so important to people who have so little.

In September on a cloudy, but dry Saturday Autumn Fest took place at the college. This gave our group an opportunity to tell who we are as a church and advertise all the events that took place during the Fall season. It was a very welcoming group of people that we met on the grounds of Bridgewater State University. Gloria Weinrebe, Angeleena Ciaramitaro, Diane Glass and Terry Reynolds talked about our church and passed out goodie bags to children and fliers with information about the church to teens and adults.

In November we welcomed to our church, Maryte Bizinkauskas, an opera singer from BSU. She is currently in the music department of the University. She agreed to help with a fund raiser called "A Night at the Opera with Maryte Bizinkaukas". Maryte entertained townspeople and members of the church with many beautiful songs. The second part of the evening Maryte invited one of her students to sing a solo and also sing a song with her. Following the performance a reception and raffle table was held. It was a wonderful evening enjoyed by all. Barbara Morey spearheaded this event and was assisted by Diane Glass.

December was the busiest month. It began with Christmas on the Common. As families wandered around the common enjoying the vendors our doors were open so people could use the restrooms. While in the building, they had an opportunity to come and shop the tables of the Church Fair Crafters and Jewelry. The children had an opportunity to use markers to decorate white pumpkins creating a snowman. The pumpkins were donated by Dave Hanson. Warmth in Cold Places is another event that church members always look forward to. People donated socks, mittens, hats, scarves, sweatshirts, sweaters and warm jackets for Warmth in Cold Places. On December 18<sup>th</sup>, a rainy, windy Monday, the group from the church set out for Taunton carrying all the clothing donated by you. Surprisingly the weather did not keep people away. The recipients, about 30 people, were very grateful as well as caring to one another. They wanted to make sure others received their share.

In the month of January, the children in the Kid's Church began preparing for the Heifer project by making crafts to sell at the Living Gift Market in February. Food was made at home with children helping parents creating rabbit cookies, chicken treats etc. all to be sold at the Living Gift Market. These activities were led by Krissy Cannizzo, Eric Stotts and parents. The children were able to raise over \$1330 which was sent to Heifer Project to purchase 3 bee hives, 2 biogas stoves (runs on methane gas), 3 hope baskets (rabbits and a flock of chicks), 1 heifer, 1 water buffalo, 2 seed packs (fruit and vegetable seedlings and saplings), and 1 goat, all of which will be given to various families in need. The families receiving animals will be trained in their care and feeding.

As part of our responsibilities, we watch over the following groups ready to assist where needed. We are responsible for aiding the breakfast program, the Women's Guild & Fellowship, the Bridgewater Food Pantry, and Heifer Project.

### **Future Plans**

Speaking of Heifer Project, watch for the traveling cows. You may find one on your lawn next winter. The cows Faith, Hope, and Charity are returning.

A Harry Potter fundraiser is being considered for next year. We must first receive approval from the Warner Bros. Consumer Products Group before we can move forward with planning the event.

The team is planning on opening the doors of the church for the July 4<sup>th</sup> parade attenders and allow them access to the bathrooms. Water will be available.

The team will revisit the idea of participating in a Service Project.

We are sad to say goodbye to Krissy Cannizzo as she will no longer be a member of the team. She will still be working with us for she will continue with Heifer Project. Krissy, thank you for all your knowledge and your imagination.

### Report of the Church Fair Committee

Friday, Nov. 3, 2023: 6:30pm-8:30pm (Pie Night!) \* Saturday, Nov. 4, 2023: 9:00am – 1:00pm

Turkey Dinner Takeout: Sunday, November 12

Christmas on the Common event: December 3

The 2023 fair included: a baked goods table; a candy table; raffle baskets; soups (8 different kinds donated in crockpots by volunteers) and walking tacos for lunch; church crafters; jewelry table; attic treasures; the harvest table, and pie night. Attic treasures was located on a limited basis in the Fireplace Room on Friday evening, and then moved out to the front lawn for Saturday, except for their Christmas merchandise (that stayed in the Fireplace Room). Thankfully the weather cooperated! It's great having it outside. The harvest table was in the Fellowship Hall Friday night for Pie Night, and set up outside on Saturday.

Because attic treasures and the harvest table were outside on Saturday, the crafters were able to take up a generous amount of room in the fellowship hall, along with baked goods, candy, jewelry, and raffle items. Volunteers made cookies, pies, and candy for the fair; made craft items; donated or procured gift baskets and gift items; worked selling raffle tickets and food. There was a volunteer or two who coordinated each of the special tables and the lunch service.

We were an approved community service opportunity for Bridgewater-Raynham High School students, and had several students working various shifts on Friday evening and Saturday (most of them all day).

The fair committee also hosted a turkey dinner takeout event again, where people could pre-order turkey dinners-for-two. It was catered by Boston Tavern Middleboro, and we added donated desserts, and was held on the weekend following the fair (11/12). Distribution was once again done in the library parking lot.

The turkey dinner takeout price was \$40 per dinner-for-two. We had 54 takeout meals purchased. An anonymous angel stepped up once again and paid the Boston Tavern bill, so the church was able to keep every dollar it took in from those who ordered dinners.

Thank you to all who helped as none of this would be possible without the many volunteers who donate their time, talent, and financial support. The Friday/Saturday fair plus the turkey takeout brought in \$7,305. Crafters and the jewelry table also sold items during the Bridgewater Business Association's Christmas on the Common, held December 3. The BBA did not utilize the fellowship hall for vendors as they have in recent years, so our folks could use the entire space. (Our bathrooms were also open to the public for use during the event.) The crafters took in, on this day alone, an additional \$644, and the jewelry table took in \$103, bringing the total brought in by the Fair Committee to \$8,052. It was budgeted at \$8,000.
